WHAT'S UP AT THE LU REES ARCHIVES?

Jonathan Appleton Visit

You've heard me mention Jonathan Appleton, the teenager who created Rippa Reading while he was a teenager at Redlands School in Sydney. He came to visit his family in Sydney and came down to Canberra on 27 October (on the train!) to visit the Archives. We had 21 'personality probes' which he had included in Rippa Reading – but we couldn't tell who these people were. Here is an example of a personality prober: Who has brown eyes, blond hair, drives a Holden, liked INXS music and loved The Lion and the Witch and the Wardrobe as a child? Do you recognise this author? When I showed these to Jonathan, he knew all 21 immediately! We enjoyed his visit and he asked lots of fascinating questions. He poured over his favourites: Robin Klein and Colin Thiele. Friends who joined us for lunch included Victor Crittenden, Kathryn Ginn (the Associate Librarian at UC), Rebecca Kemble, Belinda Gamlen and myself. Jonathan is launching a new career in children's publishing when he returns to London in December.

Lu Rees Exhibition 26-27 August 2009

Many people from the Canberra community visited the exhibition. All the comments in our visitors' book were extremely complimentary. We had 2 school groups from Hawker College studying children's literature, and a group of Japanese students from Aichi University who were at the University studying English intensively. There were many individuals, and some came on both days, bringing another friend. Many thanks to all those who were able to help us out and supervise the exhibition. There was a suggestion that we should hold it every year during Children's Book Week, for the entire week, and to let schools know so they could 'book' classes in. That may be too ambitious for our limited resources, but it was a high compliment. On the Thursday, we held the professional development session for the ACT teacher librarians. It was attended by 23 people, from 10 different schools at all levels. We presented materials in the exhibition as visual literacy by examining the stories behind the six books on exhibition. We received great feedback from them.

Lu Rees Public Opening 26 August

Our formal opening of the exhibition was attended by some 75 people on Wednesday 26 August from 4.00pm-5.30pm. The food was excellent and totally woofed away! Anita Crotty, the University Librarian, welcomed everyone with some generous remarks about the value of the collection then Margaret Hamilton, our special guest and opener, gave a rousing speech with words we like to hear - the 'Lu Rees Archives is a national treasure'. We were very pleased that several children's authors and illustrators visiting Canberra schools during Children's Book Week—Pauline Deeves, Christine Aldred, Ingrid Jonach, Laura Peterson and Dianne Wolfer, attended the opening.

Shelf reading

Now complete! There were eight ACT Branch volunteers who come on Friday 9 October, and completed the majority of the task. As it turned out, this was my birthday and was duly celebrated with a delicious poppy seed cake by all who attended. We have now finished this task, and know that our books are in good order. But we still have all the signed books and for each one we are entering this information on the Library's catalogue record. A signed book is often valuable to researchers, and certainly augments the monetary value of the Archives.

Think Tank

The Archives has set up a small committee dreaming up ideas for funding the Archives. We've met twice and come up with 13 projects which should 'tug at the heartstrings', now if we could just find someone who'd like to fund these! Seriously, we do need money for so many projects, but we also need someone with expertise in locating funds and writing grants. If you are such a person, could you please contact us – we need you!

Work Experience Student

In November-December for six days, we will host an adult migrant student, Chairan Keesing, who is studying at CIT on a special program to build up workplace communication skills. She's from Indonesia and has worked with children's programs there, and sought us out for her work experience. Once she's completed this scaffolding coursework, she'll be undertaking librarianship studies at CIT. Perhaps she'll be a continuing volunteer at the Archives, we hope so!

CBCA Book Week Artwork

This artwork since Pamela Allen's 'Book Banquet' poster has now come to the Archives with the visit of Judith Russell, the National Archivist of the CBCA. The national body felt it would be more accessible in the Archives rather than in the National Library. The national CBCA archives are stored out at Hume. Another exhibition perhaps?
