We are pleased to have as many ACT representatives on the Judging Panel as we can, and Colleen has fulfilled her role admirably. Her online Judge's overview/talk shone with her depth of knowledge and passion for all the books she discussed. Justine Power also represented the ACT Branch on the National Merchandise subcommittee, which looked at various options for marketing the merchandise and what types of products to incorporate. Once again, the Children's Book Week merchandise was colourful, eye catching and useful.

We continue to focus on improving communications with our members and the broader community by working on a higher Facebook profile, keeping our website up to date, informative and appealing and by delivering a more regular eNews. This was a live, online, and recorded event that was accessed by local authors, librarians,



teacher librarians, teachers and others interested in supporting younger readers to access high quality, current Australian Children's Literature. It was coordinated by Branch President, Julie Long and Branch Treasurer, Justine Power and facilitated by ACT Committee member and CBCA Book of the Year Judge for the Younger Reader category, Colleen Caddey. This event enabled participants to explore the 2022 six shortlisted books from the Younger Reader category. Aspects of the books that were considered included details about the authors and illustrators, age range suitability, major themes and interests, literary features that make it a notable book, Australian Curriculum links and links to resources provided by publishers, the CBCA website, and Reading Australia.

# 2022 CBCA Book of the Year Awards

## Media release from National

Sweeping from beach to bush and Daintree to Antarctic, this year's Children's Book Council of Australia Book of the Year Awards capture a panorama of Australian life.

CBCA Chair Wendy Rapee said diversity was the strength of the CBCA Book of the Year Awards and this year's record number of entries yielded a fascinating kaleidoscope of books in all six categories of award winners.

The CBC a book of the Year Awards provides us with a mirror image of our changing culture. They recognised the dedication of writers and illustrators who attend to their craft, of publishers who commit to making quality books, and the families, librarians and teachers who championed good quality literature. All are showing deep respect to Australia's young readers, and they deserve it.

At the time of continuing uncertainty, it is our privilege to award a record prize pool that supports the professional growth of Australian creatives and the imaginations of our young people. The excellence embodied in Australian children's literature today is a significant contribution to our cultural well-being.

For the first time this year, the CBC, a book of the Year awards- judged by a hardworking and passionate team of expert adult judges- have been shadowed by young readers in in the



nationwide CBCA Sun Project: shadow judging.

CBCA Book of the Year Older Readers was awarded to Rebecca Lim's, beautifully written *Tiger Daughter* a take a tale weaving its way through the challenges and injustices of culture based domestic violence. And discrimination. Two exceptional honour books. *How to repaint a life* by Steven Herrick and *Girls in Boys' Cars* by Felicity. Castagna also balanced the typically difficult topics of young adult fiction with emotional warmth.

The immigrant experience and challenges of identity and family loyalties are highlighted in *A Glasshouse of Stars* by Shirley Marr, winner of the CBCA Book of the Year, Younger Readers. Honour Books, *Dragon Skin* by Karen Foxlee and *Rabbit, Soldier, Angel, Thief* by Katrina Nannestad, bring real reading joy with their gripping stories and dynamic visuals.






The CBCA Book of the Year award: Early Childhood, is awarded to

books suitable for children up to six years old. For a child reading with an adult, their rhymes, rhythms and simple words create lifetime memories. This year's winner *Jetty Jumping* by and Andrea Rowe and Hannah Somerville is about the joys and fears of this quintessential Australian experience. Honour Books *Amira's Suitcase* by Vicki


Conley and Nikki Johnson walks the reader through fears about new beginnings, while *Walk of the Whales* by Nick Bland

encourages a connection with their animal neighbours and care of our shared environment.

Watery in illustrations bring a dreamy sense of wonder, while lyrical language conveys facts and technical vocabulary. In *Iceberg* by Jess Racklyeft and Claire Saxby, which won the Picture Book of the Year Award Honour Book *Stellarphant* by author illustrator James Foley revolves around the appealing character of Stella, a problem-solving girl astronaut who



happens to be an elephant. A colourful world created by illustrator Christopher Nielsen reinforces the text by Margrete Lamond and Anthony Bertini in *Just One Bee*. The book encourages readers to act and not stand by feeling helpless.



*Still Alive Notes from Australia's immigration Detention System* by Safdar Ahmed won the Eve Pownall Award from a challenging and diverse field of information books suitable for readers aged up to 18. *Still Alive* represents a visual, personalised account of the history and treatment of asylum seekers and refugees which has been such a pressing national issue under successive Australian governments.

*Heroes, Rebels and Innovations* by Karen Wyld and Jaelyn Blumaiwai is a highly engaging Eve Pownall Honour Book which tells the story of each indigenous achiever twice - once in poetic lyrical style, the other in a more conventional non-fiction form. *The Illustrated* 

*Encyclopaedia of Particular Pairs in Nature* by Sami Bayly is a worthy addition to her award-winning series, combining fun and facts with high quality illustrations.

The CBCA Award for New Illustrator recognises a new or emerging Illustrator, providing an important springboard. Previous winners including Shaun Tan and Freya Blackwood, have become leading artists in the field. This year's winner Michelle Pereira, for *The Boy Who Tried to Shrink his Name* - was recognised by the judges for her appealing retro illustrations created with

a colour palette drawn from the Indian flag and using bold strokes and splattered detail. The illustrations and text convey the difficult balance between being different and celebrating cultural heritage.

The ACT had 11 funded school groups participating. 1x college,  $2 \times high$  schools and  $8 \times primary$  schools.

The funding for the purchase of a category of books and an author visit was greatly received and we appreciate the Book Cow bookshop in Kingston for making the access to the books as smooth as possible. Every group, and their facilitator, was supported by a mentor from our branch.

The author and illustrator visits from local Creators were a wonderful addition to the project. Emma Allen, Harry Laing and Tracey Hawkins did multiple sessions with great success.

It was amazing to see the variety of creative responses uploaded to the Shadow Judging website and shared at the CBCA Book of the Year announcement.







We very much look forward to doing the project again in 2023, with a lot clearer of an idea of what we are required to do and a better grasp of meeting the deadlines of the project. We all learnt a lot about the judging process and the criteria but would all like to know a lot more about the process.

The Shadower's Choice Awards were exciting and gives our students a voice when it comes to the shortlist. The Awards video was a very professionally put together and a great way to finish the project.

## CBCA Children's Book Week Merchandise

The National Merchandise Subcommittee developed the 2022 CBCA Book Week merchandise range from artwork created by Jasmine Seymour for the theme *Dreaming with eyes open....* 

The 2022 CBCA Book Week merchandise range comprised standard products: CBCA Book Week poster, Shortlist poster, bookmarks (packs of 30), round stickers on an A4 sheet, bunting, button badge and enamel

pin, plus lanyards and metallic pens. The 2022 range also featured two digital products, the Yearly Planner, and the Colouring Poster. New products included a mousepad, set of three wall decals, large see-through glass decal, and hanging acrylic birds. Pull up banners were available in the premium range from Vista Print, as a produce-on-demand product. 2022 also featured new bundled packs of items and an easy all in one display product called Book-Week-in-a-Tube, which sold exceptionally well even in an up-sized version.

Selected products were available in bulk packs with slightly discounted prices. These proved hugely popular and will be featured in the 2023 season.


The 2022 CBCA Book Week merchandise range was sold nationally via the CBCA eStore (NOP Commerce) and only supported by the branches eStore representatives locally. It was agreed late in 2021 that the branches would provide promotional assistance through local channels for the sale of merchandise and advise members and state customers that the Purchase Ordering system would not be available. All ordering needed to be completed by credit card payment. The branches would then charge CBCA National 20% of the sales attributed to their state.


# Communications



The CBCA ACT Branch is pleased to be able to continue to support the National Centre for Australian Children's Literature, at the University of Canberra, through a portion of its annual membership dues.

We were able to arrange a tour of the Centre for our members in May and follow along with their many projects this year.

#### **Executive Summary**

In late November 2021, the Centre settled comfortably into its new shopfront in the University of Canberra Hub. Here it has a lively and visible presence with a new facility to showcase artworks with display areas that attract and inform visitors. The new workplace for volunteers is particularly amenable to collaboration with additional spaces for private meetings. In February 2022, the Centre welcomed its new Board Chair, University of Canberra's Professor Tracy Ireland who brings with her a wealth of cultural heritage knowledge and experience to augment the Centre.

The Centre is committed to collecting, preserving, documenting and sharing the stories that touch our hearts and stir our imaginations both as children and as adults. We continue to be guided by our <u>objectives</u>.

As an Affiliate of the University of Canberra, the Centre's resources are valued for insurance purposes every three years. The Centre's collection is valued at \$12,824,100 as of the end of June 2022.

- Enhanced the book collection through donations from publishers, individuals, organisations and Centre purchases

- Created and enhanced relationships with related organisations
- Expanded online access to the Centre's book collection, artworks and guides to authors' papers and manuscripts

#### A brief history of the Centre

The Lu Rees Archives was established in 1974 by the ACT Branch. In 1979 worked commenced on collecting the foreign language editions of Australian children's authors and illustrators. With the collection growing a more public location was sought to house the collection, in July 1980 the collection was accepted by the College Council. The Children's Book Council retained ownership of the collection, and the College Library to house, catalogue and provide support.


A management committee separate to the ACT Branch was established in 1983 and a formal agreement to house the Archives was made in

1991 with the University of Canberra. A Deed of Acknowledgement was made in 2013 between the Archives and ACT Branch when the archives became a separate incorporated organisation.

In 2016 the Archives changed their name to the National Centre for Australian Children's Literature (NCACL) and are now a registered charity.



## **CBCA National Board**

As the ACT Director on the National Board, I attended monthly Zoom meetings and liaised closely throughout the year with the Royal Australian Mint as part of the National Partnerships subcommittee. The Mint was a sponsor of the June National Conference Dinner at which the newest book and coin set "Diary of A Wombat" was announced, with both Bruce Whatley and Jackie French present. Work continues in the lead up to the production of the next book and coin set for 2023.

As in 2021, all events surrounding the CBCA Book of the Year Awards process were announced online. This has enabled the Notables, Short List and finally the Winners to be transmitted to a huge audience in an entertaining and informative way. Congratulations must go to the team from the National Board that make this possible, but especially to Jane Moore from South Australia who is the driving force and creative brain behind it all.

With the aid of an Australian RISE (Restart Investment to Sustain and Expand) grant, the inaugural National Shadow Judging process was rolled out. All States and Territories took part, using funds from the grant to support creatives to visit schools and for schools to purchase books from their chosen Short List category. Student responses could be loaded onto a Shadow Judging site. There were artworks, videos of dramatic performances, poems, alternate cover illustrations and many other types of responses to the books that the students read and re-read to become immersed in the author's message and the illustrators' interpretations. The schools voted and the results were announced nationally. Justine Power and Rachael Hind were the ACT representatives who worked on this initiative.

At a strategic Planning meeting in Melbourne in early November, the National Board added a Purpose "To enrich young lives through Australian stories" and amended our Vision, Mission, and Values to reflect this new direction. Our future deliberations will have this focus. *Julie Long (ACT Director)* 

#### Some of the initiatives of CBCA nationally

Thirteen Australian professional associations, organisations, foundations, and councils, together representing thousands of English and literacy educators, authors, artists and community members, have collaborated to develop a series of online presentations that celebrate the power

of literature and form a free Literature Symposium for 2022. The series begins in June and concludes in mid-November.

With sessions on everything from conversations with authors, artists, educators, and young learners, to short keynotes to panel discussions, the symposium explores literature from all angles – and highlights how story should be incorporated into learning and development across the curriculum.

Each free, online event will be useful for teachers, librarians, school leaders, early years educators, parents, and carers, and all interested in ensuring there is rich literature in every home, preschool, classroom, and library.

This beautifully designed coin is a glimpse into the life of a very busy wombat and is the second release in a collaboration between the Royal Australian Mint and the Children's Book Council of Australia that celebrates the pleasure of reading.

Cheeky, hungry, and sleepy, this clever wombat has humans wrapped around its little paw. This year, The Diary of a Wombat celebrates 20 years since it was first published.


Being part of the Younger Reader panel and the overall CBCA Book of the Year Awards Team is life giving, challenging, inspiring, as well as lots of fun.


# Finance


Committee, organising the annual Christmas Book Appeal and

He travelled widely and always contacted children's authors and illustrators all over Australia and internationally to interview them for Reading Time. He was a financial member of both NSW and ACT Branches for many years as a way of supporting the smaller ACT Branch. He was passionate about Australian children's books and had an enormous personal collection. His contribution to CBCA was very significant. He received his OAM in 2016 for service to children's literature. His work over the years had a positive and far-reaching influence on the development of Australian children's books and publishing and he gave encouragement, advice and even practical assistance to countless authors and illustrators of children's books.



He lived in Wagga Wagga and served in a ministry capacity at both St. Paul's Turvey Park and St. Alban's Kooringal over many decades. He continued to serve in the pastoral and sacramental ministry at St Alban's.
